The internal vacancies arising out of cancellations (due to upward movement), if any, will also be filled in this round. Further, if any vacancies arise on 10/08/2018, before the closure in respective branches, the same will also be taken up during this itself.

Candidates are advised to keep all the documents ready (originals + two photocopies) along with the Demand Draft /Pay Order of Rs. 1,57,706/- drawn in favour of “**The Principal, Dwarkadas J. Sanghvi College of Engineering, Mumbai**” while reporting for admission. **Candidates may note that, even if he/she may have secured admission in this college through the DTE CAP in any category, they will still have to produce the above mentioned DD/Pay Order, if they are to secure the vacancy round seat. Subsequently, if admitted, they can cancel their previously secured seat & secure the refund.**

Candidates, who have completed their 12th standard from a board other than Maharashtra state board will have to produce an additional Demand Draft/ Pay Order of Rs. 1000/- drawn in favour of **“The Principal, Dwarkadas J. Sanghvi College of Engineering, Mumbai”** for the purpose of verification process for obtaining the eligibility from the University of Mumbai.

Please note that the list of relevant documents required for securing admission has been put up on the college website on 28th June, 2018. You may note that the DD & the list of documents are to be made compulsorily available at the time of admission, without which the admission will not be offered.

Candidates will be called as per the merit order and if at that time, they do not possess the requested documents and the D.D./Pay Order, that particular seat will be offered to the next eligible candidate on the spot. Candidates are requested to promptly produce the required documents & the DD as applicable at the time of their admission.

Candidates are clearly advised to note that the seat will be allotted to them, only in case a vacant seat is available as and when their turn comes. If the seats are already filled up, by the time the turn of the candidate comes in the order of merit, they will have to wait for further vacancy round before the cut-off date of 14th August 2018.

Please Note:- Candidates, who have already secured admission in the previous round (ILS) and wishes to upgrade their branch in this vacancy round are required to bring the original Fee Receipt (Issued in Previous Round) as well as a demand draft of Rs.1000/- (transfer fee) at the time of admission.

Candidates, who may have cancelled their admission after securing a seat in a previous round (ILS) and want to come back and upgrade the branch (i.e. as part of fresh admission) in this round are required to bring a new Demand Draft/Pay Order of Rs. 1,57,706/- as well as all other relevant documents/retention certificate at the time of admission.
