**ACADEMIC YEAR 2021-2022.**

In continuation to the Notice dated, 6<sup>th</sup> July 2021 and 8<sup>th</sup> November 2021, the eligible students wishing to avail the EBC benefit during the Academic Year 2021-22 will have to submit the below mentioned documents in the college, as per the following schedule.

**Documents Required:**

- 1) Application on Plain Paper.
- 2) DTE CAP allotment cum admission letter (Final Admission in DJSCE with college stamp).
- 3) Original Income certificate from Tahasildar office for financial year 2020-21. (Annual Income less than Rs.8.00 lakhs).  
\*If Income certificate is not in the name of the father, relevant documents like : father's death certificate/Divorce paper are additionally required.
- 4) Affidavit/Undertaking in a prescribed format on Rs.100/- non-judicial stamp paper.
- 5) Photocopy of Ration card for identifying the number of children in family, as only 2 children are eligible for the scholarship benefit.
- 6) Declaration Certificate of parents/guardians about the number of children beneficiaries (Format on MAHADBT Portal).
- 7) Marksheet of Previous year (self-attested copy).
- 8) Domicile Certificate of Maharashtra State.
- 9) Aadhar seeded Bank account details of student along with Passbook 1<sup>st</sup> page copy and Mobile Number in a prescribed format.
- 10) Aadhar card copy.

**Schedule for documents submission (Extended date):- On 17<sup>th</sup> Nov 2021 and 18<sup>th</sup> Nov 2021- Between 2:00 pm and 4:00 pm.**

All the documents submitted in the college will be verified and the outcome of verification of the acceptance or rejection will be conveyed to the students through email, as available in the SAP records. Accordingly, students will have to pay the college fees as per verification outcome of their application.

Students receiving email from college for payment of half fees and fail to submit the documents for verification will have to pay the entire fees to the college as prescribed by the Fees Regulatory Authority (FRA).
