- 3) Original Income certificate from Tahasildar office for financial year 2023-24. (Annual Income less then Rs.8.00 lakhs. Except SC/ST)
 - *If Income certificate is not in the name of the father, relevant documents like: father's death certificate/Divorce paper are additionally required.
- 4) Original Affidavit/Undertaking in a prescribed format on Rs.100/- non-judicial stamp paper. (<u>Undertaking Link EBC</u>) (<u>Undertaking Link OBC/SBC/VJNT</u>) (<u>Undertaking Link SC/ST</u>)
- 5) Photocopy of Ration card for identifying the number of children in family, as only 2 children are eligible for the scholarship benefit.
- Declaration Certificate of parents/guardians about the number of children beneficiaries (Format on MAHADBT Portal).
- 7) Marksheet of Previous year (self-attested copy).
- 8) Domicile Certificate of Maharashtra State.
- 9) Aadhar seeded Bank account details of student along with Passbook 1st page copy and Mobile Number in a prescribed format. (Bank details format link)
- 10) Aadhar card copy.

Schedule for documents submission: From 04th July 2024 to 12th July 2024. (Between 10:00 am to 12:30 pm and 02:00 pm to 04:30 pm)

All the self-attested documents submitted in the college will be verified and the outcome of verification of the acceptance or rejection will be conveyed to the students. Accordingly, students will have to pay the college fees as per verification outcome of their application.

Students receiving email from college for payment of half fees and fail to submit the documents for verification will have to pay the entire fees to the college as prescribed by the Fees Regulatory Authority (FRA).
